Join Our Office Smart Dental Plan

You never have to hassle with a dental insurance company! You can say goodbye to high monthly premiums!

You have the freedom to choose the treatment best for you! No downgraded treatment!

You can get exact pricing – no more estimates! You never get denied coverage again!

Our office Smart Dental Plan (SDP) is an annual reduced-fee savings plan (NOT an insurance plan) for families and individuals that allows all SDP members to receive quality dental services at greatly reduced prices. Unlike conventional dental insurance plans, with SDP there are no deductibles, no yearly maximums, and no waiting periods to begin treatment. SDP benefits coverage begins immediately on plan registration and payment.

Benefits covered for a period of one year from the date of the paid contract :

Covered at 100% - (2) exams (D0120, D0150, D0140) and routine cleanings (D1110, D1120) per year, all x-rays (D0210, D0220, D0230, D0270, D0272, D0273, D0274, D0330) except for 3-D imaging, (1) fluoride treatment per year (D1206, D1208), (1) annual oral cancer screening.

20% discount applies to all fillings, crowns, sealants, dentures and denture repairs, orthodontics, extractions, bleaching, single implant procedures (single implant, abutment crown), natural teeth bridges, periodontal treatments, laser treatments, and any exams and routine cleanings outside the ones covered above (such as a 3rd exam or cleaning for the year or a TMJ/detailed exam).

Discount does NOT apply to 3-D imaging (CT scans), Botox, dermal fillers or products sold in-office such as electric toothbrushes, prescription rinses or toothpastes, or full mouth implant retained denture procedures such as an "All on 6" or "All on 4".

Limitations :

Benefits of plan are only available in our office - this plan is not part of any other insurance or discount plan.

Services cannot be filed to dental insurance. If services are filed by the patient, the SDP contract is canceled and no refund or compensation will be considered.

Plan benefits not available with any other discount offer.

Plan benefits are available from the date of the paid contract forward - benefits are not retro-active.

The cost is only \$350/year for the first family member, \$300/year for each additional family member. Eligible family members include legal spouse and dependent children under the age of 23. Plan duration is for 12 months from the registration date. Benefits are available only at the dental office of Dr Ray A Morse.

Any fees for dental services are due when the services are rendered. Fees for prosthodontic (dentures) and indirect restorations (crowns, bridges, veneers, inlays, onlays) are due on the preparation/impression appointment. Fees for single-appointment CAD/CAM restorations are due on the date of service. Member benefits may not be used with any other offers or insurance plans.
